U.S.-Japan Trade Agreement

Poultry and Egg Products

Overview: In 2023, the United States exported \$88 million of poultry and eggs products to Japan, making Japan the #13 overseas market. Japan is a major importer of frozen chicken legs. The United States accounted for one percent of Japan's poultry imports and 21 percent of its egg imports. The years below correspond to Japan's fiscal year beginning April 1.

Market Considerations: Poultry meat consumption has risen steadily in Japan over the past several decades. Japan imports around 40 percent of its chicken meat supply with the majority of raw and processed products coming from low cost suppliers in Brazil, Thailand, and China. Under this agreement, the United States gained a tariff advantage over each of these countries. Japan's market for turkey, though small, has doubled in size over the past five years and is growing rapidly. The United States is the dominant supplier of turkey meat to Japan. Japan is a major importer of egg ingredient products for further processing into mayonnaise and other prepared food items. On April 1, 2023, USDA APHIS and MAFF agreed to lower HPAI-related trade restrictions on U.S. poultry products exported to Japan. Bans on exports from HPAI affected zones are now eligible to have restrictions lifted 28 days post cleaning and disinfection (down from 90 days).
