## U.S.-Japan Trade Agreement Fruit Juice and Jams

**Overview:** In 2024, the United States exported \$31 million of fruit juice and jams to Japan, making Japan the #3 overseas market. The United States accounted for five percent of Japan's total fruit juice and jam imports. The years below correspond to Japan's fiscal year beginning April 1.
