U.S.-Japan Trade Agreement

Fruit Preparations

Overview: In 2023, the United States exported \$25 million of prepared or preserved fruit (excluding jams) to Japan, making Japan the #5 overseas market. For jams, see the Fruit Juice and Jams product brief. Japan relies on imports for nearly 90 percent of its demand for processed fruit. The United States accounted for five percent of Japan's total prepared and preserved fruit imports. The years below correspond to Japan's fiscal year beginning April 1.
