Japan Revises Organic Law Allowing Imported Organic Feed

Report Highlights:

Effective April 26, 2017, Japan accepts the use of imported organic certified animal feed from countries that share an organic equivalency arrangement with Japan, allowing imported organic feed to be used in the production of organic compound feed, or to be fed to organic livestock.

General Information:

On Monday, March 27, 2017, Japan's Ministry of Agriculture, Forestry and Fisheries (MAFF) announced the revision of the Japan Agricultural Standard (JAS) Law for the feed of organic livestock. Effective April 26, 2017, Japan unilaterally recognizes imported feed that is certified organic from countries that share an organic equivalency arrangement with Japan (i.e. the United States, Argentina, Australia, Canada, the European Union, New Zealand, and Switzerland) as certified for use in the production of organic compound feed, or for feeding to organic livestock. Interested parties in the United States considering export of these organic feeds to Japan are required to provide documentation of their certification under the USDA National Organic Program.

Documentation of organic certification is not required for the export of organic feed that is intended for non-organic use, such as the production of non-organic compound feed, or provided as feed to non-organic livestock.

Included below are provisional translations of the Japan Agricultural Standard (JAS) law for organic ingredients and feed. Revisions to the law are indicated in red text.
