#### **Report Highlights:**

On April 25, 2019, Japan notified the World Trade Organization of draft amendments to the maximum residue levels (MRL) for the feed additive, Butylated Hydroxyanisole, via <u>G/SPS/N/JPN/637</u>. There will be no public comment period established for this proposal as this proposal relaxes the regulation. #### **General Information:**

On April 25, 2019, Japan notified the World Trade Organization of draft amendments to the maximum residue levels (MRL) for the feed additive, Butylated Hydroxyanisole, via <u>G/SPS/N/JPN/637</u>. 2. "Other fish" refers to all fish, except Salmoniformes, Anguilliformes and Perciformes.
